The rationales for ongoing clinical trials are clearly articulated as well as the importance of ongoing clinical investigation. The authors have filled the book with tables, graphics, relevant pathology figures, and other illustrative images, making it visually stimulating. Flowchart and diagrammatic

algorithms are supplied to provide readers with a practical guide to the diagnostic and therapeutic strategies used at MD Anderson. Numerous chapters address important palliative and supportive measures, such as oncologic emergencies, infections, endocrine manifestations of non-endocrine tumors, palliation, and long-term followup.
