Lord Roberts' took first place. I made a reference to this the other day. Since then I have looked up Lord Roberts' words. He followed Mr. Haldane, as he was then, who said that the plans which were in process of completion would guarantee the empire a strong defence in twenty years. Lord Roberts said that he thought twenty months would be more in order, and he used this language: "A shot fired in the Balkan peninsula might produce an explosion which would change the fortunes of every remotest colony of our empire." That was the most remarkable example of prophecy that the conference could have produced (hear, hear). Many other speakers at the first conference felt in view of the imminence of the danger and its gravity that the time had arrived for formal engagements with regard to measures of defence and the creation of machinery to bring that defence into action, and more than one resolution of this character was submitted to the conference. They were not, however, forced to a vote because there were others who held contrary views, who believed that the policy was not in harmony with the evolutionary trend of events in the British empire and that the methods proposed were not of a practicable character. That view simply reflected similar differences of opinion throughout the empire. In all the dominions there were two well defined groups in reference to the question of imperial organization. One was the school of Burke, who placed very little reliance on forms and a great deal of reliance on spiritual ties and the bonds of blood. The other might be called the school of Hamilton who held that sentiment was very well but not very practical unless set forth categorically as obligations, with some

and economic triggers have been identified to resolve or reduce violent conflict and disorder. The research used primary as well as secondary sources to study the issues and explore the problems inherent in an environment of scarce resources. Confrontations between the state and society were brought to a higher level of violence since the late 1970s following the Somali-Ethiopian war. The author explored avenues for reconciliation and nation-building and introduced several models as possible strategies for nation-building. Conclusively, a home-grown, traditional mechanisms model was recommended which entails the following policy prescriptions to achieve long-lasting peace and security for Somalia: 1. Governance structures of law and order. 2. Resources: De-escalating conflicts by opening up negotiating opportunities of land and property. 3. Complete demilitarization of society. 4. International cooperation. A plan by the international community to reconstruct and rehabilitate Somalia is essential if we have to avoid a relapse into a chaotic, violent situation in Somalia.

There are presently clear indications that we are about to see a revival of nuclear energy worldwide. It is important to make this expansion of nuclear energy for the production of electricity and desalinated water as safe and secure as possible. In the coming decade, however, the rate of this expansion will be limited by several factors: in recipient states, by the lack of an adequate industrial infrastructure or an insufficient nuclear safety culture with a truly independent control organization; and in supplier states, by a limited capacity to produce certain types of nuclear equipment, such as reactor vessels. Since there is no rush, we have time to “do” nuclear right. Doing it right means, in particular, putting stronger barriers to proliferation in place before, not after, new nuclear capabilities spread. The present analysis has identified five areas (among many others) where the United States, Russia, and the European Union should closely cooperate in order to strengthen the nonproliferation regime: enforcing UN Security Council resolutions on Iran; addressing cases of noncompliance; improving security of supply and discouraging the spread of sensitive technologies; strengthening export criteria for the Nuclear Suppliers Group; and preparing the 2010 Nuclear Non-Proliferation Treaty review conference. This study is part of a series being published by the joint CSIS/IFRI project “Europe, Russia, and the United States: Finding a New Balance,” which seeks to reframe the trilateral relationship for the relevant policymaking communities.

During World War II, Japanese fighters, such as the famed Zero, were among the most respected and feared combat aircraft in the world. But for decades following the defeat of Japan in 1945, a variety of political and economic factors prevented Japan from developing its own modern national fighter. This changed in the 1980s. Japan began independently developing its first world-class fighter since World War II.
