Demographic factors, such as an ageing population, and changes in work practice and social and political policy, mean the need for advice on the effects of

medical conditions on employments and working capability is increasing. In keeping with previous editions, chapters are organized by medical condition, and co-authored by both a topic specialist and a specialist occupational physician. The reader will find practical guidance on the employment potential and assessment of anyone with an illness or disability. There is additional coverage of the ethical and legal aspects of ill health at work. There is an attempt to include, where possible, the evidence base and guidelines behind the findings. This update also reflects recent government focus on a more holistic approach to health problems in employment, and initiatives to encourage people to stay at work and return to work, rather than supporting them at home. To an extent, occupational medicine must be tailored to individual patients under unique and specific circumstance. However, this book provides a wealth of useful consensus guidance, codes of practice, and locally evolved standards, to enable clinical judgements to be made. It is the most comprehensive text available on the effects of ill health on employment.
